WHEREAS, the County of Fresno, Fleet Services, Organization (Org) 8910, requires additional funds in the amount of \$48,948 to be used to fund the salaries and benefits of two Heavy Duty Mechanics to meet the service needs of the Public Works and Planning – Roads Division; and

WHEREAS, the costs of said additional positions will be fully funded by charge backs to the Public Works and Planning – Roads Division from services provided in the amount of \$48,948; and

WHEREAS, said monies are not included in the adopted appropriations for the FY 2025-26 Fleet Services, Org 8910; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2025-26 Fleet Services, Org 8910 as follows:
