WHEREAS, the Willow Avenue-Shepherd to Copper Improvements Org 1334 had previously received funds related to traffic mitigation from developers/builders for Willow Avenue-Shepherd to Copper improvements and interest, in the amount of \$60,990; and

WHEREAS, the project is now complete and the City of Clovis is requesting reimbursement of remaining funds in Org 1334; and

WHEREAS, \$60,990 is available in the fund balance of the Public Facilities Fees Special Revenue Fund 0088; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2025-26 Willow Avenue-Shepherd to Copper Improvements Org 1334; and

WHEREAS, section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to establish the appropriations in the FY 2025-26 Willow Avenue-Shepherd to Copper Improvements Org 1334 as follows:
