#### Dear Chairman Mendes:

As part of the Williams Lawsuit Agreement of 2004, California Education Code Section 1240 requires that we visit schools identified in our county and report to you the results of these visits. Attached is information on the Williams Lawsuit Settlement Agreement implementation by the Office of the Fresno County Superintendent of Schools.

This annual report concerns the visits to 120 of our county schools August through September 2025, as well as a review of the School Accountability Report Cards for the 2023-2024 school year, which was published in February of 2025. Teacher misassignments are no longer part of the Williams Report as the California Department of Education has implemented a new monitoring process at the state level.

The purpose of these visits, as specified in California Education Code Section 1240 was to:

- Ensure that the students have access to "sufficient" instructional materials in four core subject areas (English/Language Arts, Mathematics, History/Social Science, Science) and, as appropriate, science laboratory equipment, foreign languages, and health;
- Assess compliance with facility maintenance to identify conditions that "post an emergency or urgent threat to the health or safety of pupils or staff" and ensure facilities are in good repair; and
- 3. Determine if the school has provided accurate data for the annual School Accountability Report Card related to instructional materials and facilities maintenance.

The standards set forth in the law define "sufficient" instructional materials as meaning that every pupil, including English learners, have textbooks in the four core areas for classroom use and to take home. Facilities standards specifies each school district that receives state funding for facilities maintenance is required to establish a facilities inspection program and ensure that each school is maintained in good repair which is defined as maintaining schools that are clean,

safe, and functional. The School Accountability Report Cards are updated to report the information required by the Williams Lawsuit Settlement Agreement. In conclusion, the Fresno County Superintendent of Schools is available to support the districts in our County with any of their educational needs.
