IN THE MATTER OF DISSOLVING THE REVOLVING)
CHANGE FUND AT HERITAGE ESTABLISHED BY) RESOLUTION
THE DEPARTMENT OF BEHAVIORAL HEALTH)
ORG 5630 IN THE AMOUNT OF \$50)

WHEREAS, each reference in this resolution to the County Auditor, the County Treasurer, or the County Tax Collector refers to the relevant office and its lawful function as may be, and currently is, consolidated within the office of the Auditor-Controller/Treasurer-Tax Collector (“ACTTC”); and

WHEREAS, Government Code section 29321 provides that the Board of Supervisors (“Board”) may establish a revolving fund for the use of any officer of the County by adopting a resolution setting forth: (a) the necessity for the fund, (b) the office, department, service, or institution for which the fund is available, and (c) the amount of the fund, which shall not exceed Two Hundred Fifty Thousand Dollars (\$250,000); and

WHEREAS, Government Code section 29330 provides that the Board may at any time discontinue any revolving fund established by its order and if the fund is discontinued, the officer responsible for the fund shall immediately refund it to the County Treasurer; and

WHEREAS, in compliance with Section 5.2 of the County of Fresno Cash Manual, the Department of Behavioral Health, on October 3, 2025, sent a memo to the ACTTC seeking formal approval to close Heritage Centre Cash Fund in the amount Fifty Dollars (\$50), and the ACTTC approved the request for dissolution; and

WHEREAS, The Department of Behavioral Health ORG 5630 requests the Board, pursuant to Government Code section 29330, to discontinue the Revolving Change Fund at Heritage in the amount of Fifty Dollars (\$50), as it is no longer necessary.

1 NOW THEREFORE, BE IT RESOLVED, that the Board hereby discontinues and
2 dissolves the Department of Behavioral Health ORG 5630 Revolving Change Fund at Heritage
3 in the amount of Fifty Dollars (\$50), and directs the Department of Behavioral Health and
4 ACTTC to take all necessary actions to discontinue and dissolve this Fund.
