IN THE AMOUNT OF \$165,083)

WHEREAS, funds are needed to cover expenditures related to the implementation and first-year subscription of the Accela Software system; and

WHEREAS, \$165,083 is available in FY 2025-26 actual revenues collected in the Admin Fines - Code Enforcement Org 1188 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations of the Code Enforcement – CAO Org 4620; and

WHEREAS, the Code Enforcement – CAO Org 4620 will receive \$165,083 as an Operating Transfer In from Admin Fines – Code Enforcement Org 1188 to cover expenditures related to the implementation and first-year subscription of the Accela Software system; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 Code Enforcement – CAO Org 4620 as follows:
