

1 **Resolution No. 24-_____**

2 **A Resolution of the Board of Supervisors of the County of Fresno Establishing a Revolving**
3 **Fund for the Sheriff-Coroner's Office Area 2**

6 WHEREAS, Section 29321 of the Government Code provides that the Board of
7 Supervisors ("Board") may establish a revolving fund for the use of any officer of the County,
8 which includes any elective or appointive officer of the County and any person in charge of any
9 office, department, service, or institution of the County, or a division or branch thereof, by adopting
10 a resolution setting forth: (a) the necessity for the fund, (b) the office, department, service, or
11 institution for which the fund is available, and (c) the amount of the fund, which shall not exceed
12 \$250,000; and

13 WHEREAS, the Sheriff-Coroner's Office needs a revolving fund, to be used by Area 2
14 Sheriff-Coroner's Office property detectives to conduct divisional investigative activities, including
15 cultivating informants by paying the informants, controlled purchase of stolen property to further
16 criminal investigations and make arrests as a form of solving crimes, and to be used for meals
17 during ongoing investigations when employees are unable to leave a scene and for meals for
18 children of victims during interviews; and

19 WHEREAS, the Board has received and considered a report and recommendation from
20 the Auditor-Controller/Treasurer-Tax Collector concerning the matters that are subject of this
21 resolution; and

22 WHEREAS, the amount of this revolving cash fund shall be \$5,000; and

23 WHEREAS, the Sheriff-Coroner's Office shall maintain this revolving fund under its direct
24 administrative control, with periodic disbursements to the Lieutenant designated as the Assistant
25 Commander of Area 2, who will be responsible for maintaining all accounting records for the fund,
26 including records of disbursement, reimbursement, consignment to Detectives, and when
27 applicable, evidence monies; and

1 WHEREAS, Government Code section 29330 provides that the Board may at any time
2 increase, reduce or discontinue any revolving fund established by its order.
