7 **COUNTY OF FRESNO)**

8 **WHEREAS**, from the beginning of time mothers have always been unique in
9 providing care and nurturance during childhood. Thus, they cannot be replaced, and
10 separation can have an impact on the child's development; children from motherless
11 homes are more likely to develop emotional issues; personality disorders like
12 narcissistic personality or borderline personality disorder are more common in children
13 who grow up without a mother; and

14 **WHEREAS**, the traditional nuclear family, consisting of one husband, one wife,
15 and any biological, adopted, or fostered children, is God's design for familial structure
16 and has been the bedrock of society since the creation of the world; and

17 **WHEREAS**, the traditional nuclear family was the basic building block of Fresno
18 County's society throughout her formative years; and the traditional nuclear family built
19 the United States of America and created prosperity within our nation; and

20 **WHEREAS**, fatherless families are four times more likely to live in poverty than
21 married couple families; seventy-five percent of youth in substance abuse centers come
22 from fatherless homes; children from fatherless homes are more likely to have mental
23 health and behavioral issues; sixty percent of youth suicides are from fatherless homes;
24 seventy-one percent of high school dropouts are from fatherless homes; fatherless
25 youths are three to twenty times more likely to be incarcerated; seventy percent of
26 youths in prison come from fatherless homes; and in a 2016 study by Peter Langman
27 on the psychology behind fifty-six school shooters, eighty-two percent of the shooters
28 were raised in an unstable family environment or without both biological parents
together; and

WHEREAS, children are now under attack from anti-family groups that make
every effort to indoctrinate children into the LGBTQ lifestyle, promote genital mutilation,
abortion practices and Transgender ideology without parental knowledge or consent;
and

WHEREAS, the nuclear family is God's perfect design for humanity and is
aligned with the long-held traditional values of Fresno County; and

1 **WHEREAS**, the nuclear family is under attack in our beloved State and nation,
2 and it is our responsibility to uplift, protect, and support values that help Fresno County
3 prosper;

4 **NOW THEREFORE, BE IT RESOLVED** that the Fresno County Board of
5 Supervisors hereby adopts June as " Traditional Nuclear Family Month" in the County of
6 Fresno, and commends the noble endeavors of those who seek to protect and
7 strengthen the traditional values of our State and nation.
