5 **RESOLUTION AUTHORIZING RETROACTIVE SUBMISSION OF A FINANCIAL ASSISTANCE**  
6 **APPLICATION TO THE STATE WATER RESOURCES CONTROL BOARD, TO FUND DESIGN**  
7 **AND CONSTRUCTION OF IMPROVEMENTS TO THE DRINKING WATER FACILITIES**  
8 **SERVING COUNTY SERVICE AREA NO. 14, REFERRED TO AS THE 1,2,3-TCP MITIGATION**  
9 **PROJECT, AND DESIGNATING THE DIRECTOR OF THE DEPARTMENT OF PUBLIC**  
10 **WORKS AND PLANNING TO SIGN AND FILE THE APPLICATION AND OTHER REQUIRED**  
11 **INSTRUMENTS, INCLUDING THE FUNDING AGREEMENT, AND TO GIVE REQUIRED**  
12 **ASSURANCES, CERTIFICATIONS, AND COMMITMENTS.**

13 **WHEREAS**, the drinking water produced by the facility serving County Service Area No.  
14 14 – Belmont Manor (CSA 14) exceeds the California Code of Regulations, Title 22, maximum  
15 contaminant level (MCL) for 1,2,3-Trichloropropane (1,2,3-TCP); and

16 **WHEREAS**, the State Water Resources Control Board (SWRCB) assists in the financing  
17 of capital improvements to community water drinking facilities through the Drinking Water State  
18 Revolving Fund (DWSRF); and

19 **WHEREAS**, the County of Fresno (County), through the Department of Public Works and  
20 Planning (Department), is working with SWRCB to plan improvements to connect the CSA 14  
21 water system to the City of Fresno (City) water system via a 16-inch transmission main and a  
22 master meter connection, referred to as the “1,2,3-TCP Mitigation Project”; and

23 **WHEREAS**, the SWRCB requires that the governing board of the entity applying for  
24 financing name an Authorized Representative to sign and file the Financial Assistance  
25 Application, and any and all other instruments required to complete the Financial Assistance  
26 Application of behalf of the entity; and

27 **WHEREAS**, the SWRCB requires, as a condition of funding, the governing board of the  
28 entity applying for financing also name an Authorized Representative or Representatives  
designated to provide assurances, certifications, and commitments required for the Financial  
Assistance Application, including executing a funding agreement (Funding Agreement) from the  
SWRCB and supporting documents.

1 NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO  
2 DOES HEREBY FIND, DETERMINE AND RESOLVE AS FOLLOWS:

3 **Section 1.** The Director of the Department, or his or her designee, (Director) is hereby  
4 retroactively authorized and directed to execute and file a Financial Assistance Application, and  
5 any and all other instruments required to complete the Financial Assistance Application, to  
6 SWRCB for financing under the DWSRF program for construction of improvements to the CSA  
7 14 water system, including the connection to the City water system, referred to as the “1,2,3-TCP  
8 Mitigation Project”.

9 **Section 2.** The Director is hereby retroactively authorized to execute and provide the  
10 assurances, certifications, and commitments required for the Financial Assistance Application,  
11 and is the Authorized Representative for the purpose of submitting the Financial Assistance  
12 Application.

13 **Section 3.** The Board hereby finds, determines, and represents that all of the recitals in  
14 this Resolution, and each of them, are true and correct.
