

As the City of Fresno's (City) Mayor, I am writing in support of the Foster Youth DREAM Center @ Campus Pointe (Center), a proposed 40,000-square-foot, three-story facility that would integrate academic, emotional, housing, legal, and health services under one roof, creating a unique, comprehensive program that will help young people as they transition into independence.





To further support these efforts, I authored **Senate Bill 624 – the FOSTER Act (Foster Outreach and Support for Tax Education Readiness)**. This bill aims to increase awareness and utilization of the California Earned Income Tax Credit (CalEITC) among foster youth by establishing standardized outreach efforts. By connecting more eligible young people to the financial resources they deserve, SB 624 helps empower foster youth to break the cycle of poverty and move toward long-term economic stability. The bill is currently awaiting the Governor's signature.

The Foster Youth DREAM Center is not only about providing services—it is about creating opportunities. It represents a promise that every young person, regardless of background, has the support necessary to thrive. Investing in this Center is an investment in the future of our


