WHEREAS, the Probation Org 34409999 requires \$469,934 to purchase body scanners at the Juvenile Justice Campus for provision of services to Senate Bill 823 and least restrictive placement requirements; and

WHEREAS, \$319,968 is available in the fund balance of the Juvenile Facility Grant Fund 0075, Subclass 17306, Org 1146; and

WHEREAS, \$149,966 is available in the budget of OYCR – LRP Fund 0075, Subclass 17309, Org 1149, to fund these expenditures; and

WHEREAS, said monies are not included in the adopted appropriations and revenues of Probation Org 34409999; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Probation Org 34409999 as follows:


