WHEREAS, the County of Fresno will receive \$135,693 as an Operating Transfer In from the Sheriff Special Revenue Fund 0095, Sheriff CA Standard and Training for Corrections Org 1452; HIDTA State Asset Forfeiture Org 1464 and Sheriff's Special Revenue Fund 0095, Sheriff's Special Revenue Fund 0095, Indigent Burial Trust Fund Org 1465; and Local Revenue Fund 2011 Fund 0271, Org 31190200

and

WHEREAS, said monies were not included in the FY 2025-26 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 Sheriff-Coroner-Public Administrator Organization 3111 as follows:
