10 WHEREAS, the people of the State of California have enacted the Off-Highway Motor Vehicles
11 Recreation Act of 2003, which provides funds to the State of California and its political subdivisions for
12 Operation and Maintenance, Restoration, Law Enforcement, and Education and Safety for off-highway
13 vehicle recreation; and

14 WHEREAS, the Off-Highway Motor Vehicle Recreation Division of the California Department of
15 Parks and Recreation has been delegated the responsibility to administer the program; and

16 WHEREAS, procedures established by the California Department of Parks and Recreation
17 require the Applicant's Governing Body to certify by resolution the approval to receive grant funding
18 from the Off-Highway Motor Vehicle Grant funds; and

19 WHEREAS, this project appears on, or is in conformance with the County of Fresno's adopted
20 general or master plan and is compatible with the land use plans of those jurisdictions immediately
21 surrounding the Project.

22 NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors hereby:

23 1. Approves the receipt of grant funding from the Off-Highway Vehicle Grant or
24 Cooperative Agreement Program; and

25 2. Certifies that the County of Fresno understands its legal obligations to the
26 State upon approval of the Grant; and

27 3. Certifies that the County of Fresno understands the California Public
28 Resources Code requirement that Acquisition and Development Projects be


maintained to specific conservation standards; and

4. Certifies that the Project will be well-maintained during its useful life; and
5. Certifies that the County of Fresno will implement the Project with diligence once funds are available and the County of Fresno has reviewed, understands, and agrees with the Project Agreement; and
6. Certifies that the County of Fresno will provide the required matching funds; and
7. Certifies that the public and adjacent property owners have been notified of this Project (as applicable); and
8. Appoints the Sheriff, or his designee, as agent to conduct all negotiations, execute and submit all documents including, but not limited to Applications, agreements, amendments, payment requests and so on, which may be necessary for completion of the Project.
