WHEREAS, funds in the amount of \$20,453 are not included in the FY 2024-25 adopted appropriations and estimated revenues of the DOI Workers Compensation Insurance Fraud Program Org 1107; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2024-25 appropriations of the DOI Workers Compensation Insurance Fraud Program Org 1107 as follows:
