9               WHEREAS, the Sheriff-California Standard and Training for Corrections Organization 1452  
10 will receive funding from the State of California Board of State and Community Corrections in the  
11 amount of \$28,187 in FY 2024-25; and

12               WHEREAS, \$66,192 will be available in the fund balance of the Sheriff-Coroner Special  
13 Revenue Fund 0095, Subclass 17652 to fund these expenditures; and

14               WHEREAS, said monies were not included in the FY 2024-25 adopted appropriations and  
15 estimated revenues of the Sheriff-Coroner Standard and Training Corrections Special Revenue  
16 Fund Organization 1452; and

17               WHEREAS, Section 29130 of the Government Code provides for the appropriation of  
18 these funds by a four-fifths vote of the Board of Supervisors;

19               NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector  
20 is authorized to increase the appropriations in the FY 2024-25 Sheriff-Coroner-Public  
21 Administrator Organization 3111 as follows:
