WHEREAS, the County of Fresno will receive \$378,079 as an Operating Transfer In from the Sheriff Special Revenue Fund 0095, Sheriff CA Standard and Training for Corrections Org 1452; Sheriff Special Revenue Fund 0095, Local Law Enforcement Block Org 1456, Sheriff's Special Revenue Fund 0095, HIDTA State Asset Forfeiture Org 1464 and Sheriff's Special Revenue Fund 0095, HIDTA Treasury Asset Forfeiture Org 1467 and Sheriff's Special Revenue Fund 0095, Indigent Burial Trust Fund Org 1465;  
and

WHEREAS, said monies were not included in the FY 2024-25 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Sheriff-Coroner-Public Administrator Organization 3111 as follows:
