Over time, their family grew to include eight grandchildren and two great-grandchildren. Doug and Caroline enjoyed 46 years of marriage before her untimely passing in 2003; and

WHEREAS, Doug began his career with Fresno County on February 2, 1961, as a Stock Clerk at the County General Hospital. His dedication and strong work ethics were evident from the beginning. In 1970 he transferred to the Juvenile Hall as a Storekeeper until September 1985; and

WHEREAS, after a brief departure from the County, he began working at the jail in July 1987 as extra help and was later promoted to a full-time Stock Clerk. In November 1991 he moved to the Sheriff's Office Headquarters where he has remained ever since, demonstrating unwavering dedication through his work with five different Sheriffs; and


WHEREAS, Doug's responsibilities include the storage of materials and equipment for all Sheriff's Office units, ensuring that every purchase made by the Sheriff's Business Office is accurately stocked and delivered. He takes great pride in maintaining inventory control, verifying quantities, inspecting conditions, and addressing any discrepancies; and

WHEREAS, despite the growth of the Sheriff's Office, he has remained the sole Stock Clerk, continuing to serve with compassion, integrity, and dedication to the Fresno County Sheriff's Office.

NOW THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors hereby recognize and express our deep appreciation and gratitude to Douglas "Doug" King for his remarkable and dedicated service to Fresno County. His legacy of hard work, professionalism, and devotion to his family and community will be long remembered.
