11 WHEREAS, the California Work Opportunity and Responsibility to Kids Org 6310 will not
12 receive \$9,943,120 as an Operating Transfer In from the Welfare Advance Fund Org 1120, and
13 will instead receive \$1,222,524 as an Operating Transfer In from the Local Health and Welfare
14 Trust Fund 0135, 1991 Realign-CalWORKs Moe Org 5247 due to additional Sales Tax receipts
15 from prior fiscal year State adjustments, and receive a net \$7,157,298 as an Operating Transfer In
16 from the Local Health and Welfare Trust Fund 0135, 1991 Realign-Family Support Org 5248 to
17 account additional Vehicle License Fee receipts of \$8,720,596, and a decrease of \$1,563,298 due
18 to Net County Cost savings from General Relief Org 6645 to offset the county share of assistance
19 cost in California Work and Opportunity to Kids Org 6310;

20 WHEREAS, said monies are not included in the FY 2025-26 adopted estimated revenues
21 of the California Work Opportunity and Responsibility to Kids Org 6310;

22 WHEREAS, Section 29126.1 of the Government Code authorizes the Board of Supervisors
23 to cancel any unused appropriations; and

24 WHEREAS, Section 29130 of the Government Code provides for the appropriation of
25 these funds by a four-fifths vote of the Board of Supervisors;

1 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
2 is authorized to decrease the appropriations in the FY 2025-26 Department of Social Services -
3 California Work Opportunity and Responsibility to Kids Org 6310 as follows:
