RELEASE OF DECLARATION AND EASEMENT AGREEMENT

This Release of Declaration and Easement Agreement ("Release") is dated for reference purposes only as of this _____ day of _____, 2026, and is between PACIFIC BELL TELEPHONE COMPANY, a California corporation ("Releasor"), and THE COUNTY OF FRESNO, a political subdivision of the State of California ("Releasee"). The words "Releasor" and "Releasee" shall include their respective heirs, successors, legal representatives and assigns where the context permits or requires.

WHEREAS, various easements (the "Easements") were granted to Releasor by that certain **Declaration of Easements for Communications Equipment (Olive MPOE with Equipment Room (#2))** dated December 17, 2020 and recorded on December 24, 2020 in the Official Records of Fresno County, in the State of California, as **Document Number 2020-0187030** (the "Declaration"), with respect to the real property commonly known as 5555 E. Olive Avenue, located in the City of Fresno, State of California (the "Property") more particularly described as follows:

NOW THEREFORE, Releasor, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, hereby terminates the Declaration and quitclaims and releases unto Releasee, all of Releasor's right, title and interest (if any) in and to the Declaration and right of way, easement rights, all improvements, buildings, and structures made thereon, privileges and authority granted to Releasor under the Declaration and the Easements granted therein.

RELEASOR HAS NOT MADE, DOES NOT MAKE AND SPECIFICALLY REVOKES AND DISCLAIMS ANY REPRESENTATIONS, WARRANTIES, PROMISES, COVENANTS, AGREEMENTS OR GUARANTEES OF ANY KIND OR CHARACTER WHATSOEVER, WHETHER EXPRESS OR IMPLIED, ORAL OR WRITTEN, PAST OR FUTURE, OF, AS TO, CONCERNING OR WITH RESPECT TO THE DECLARATION, THE EASEMENTS GRANTED THEREIN AND/OR THE PROPERTY. TO THE MAXIMUM EXTENT PERMITTED BY LAW, THE EASEMENTS ARE RELEASED "AS IS" AND WITH ALL FAULTS.

Each party hereto shall be relieved of any and all of its respective obligations and duties set forth in the Declaration and the Easements granted therein, and each party hereby forever releases the other party from any and all claims, demands, obligations, and causes of action which such party may have against the other party arising from or in any way connected with the Declaration or the Easements granted therein.

This Release is made and accepted subject to all restrictions, covenants, conditions, rights-of-way, assessments and easements, if any, affecting the above described Property whether of record or not.

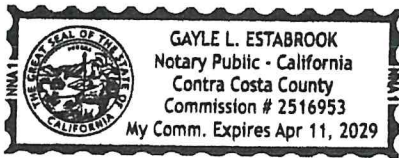
