6 CEMETERY DISTRICT BOARD OF TRUSTEES
7 FROM FIVE (5) TO THREE (3) MEMBERS

RESOLUTION

9 WHEREAS, Parlier Cemetery District is a public cemetery district governed by a five-
10 member Board of Trustees appointed by the Fresno County Board of Supervisors; and

11 WHEREAS, California Health and Safety Code section 9025 authorizes the Board of
12 Supervisors to increase or decrease the members of a cemetery district board of trustees if requested
13 by the district through a resolution adopted by the district's board of trustees; and

14 WHEREAS, on May 18, 2026, pursuant to Health and Safety Code section 9025(a), the
15 Parlier Cemetery District Board of Trustees adopted Resolution No. 04-2026, requesting the Board of
16 Supervisors decrease the District Board of Trustees membership from five (5) to three (3); and

17 WHEREAS, pursuant to Health and Safety Code section 9025(b), the Board of
18 Supervisors, at a noticed hearing, has considered the District Board's request; and

19 WHEREAS, Health and Safety Code section 9025(d) states that if the board of
20 supervisors orders a decrease in the number of members of the board of trustees, the board of
21 supervisors shall designate the trustee or trustees whose office shall be eliminated at the termination of
22 the trustee's current term of office, and any trustee whose office is designated to be eliminated shall
23 continue to serve until his or her term expires.

24 NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of
25 Fresno hereby orders decreasing the Parlier Cemetery District Board of Trustees membership from five
26 (5) to three (3) members.

27 BE IT FURTHER RESOLVED that the reduction shall be implemented through attrition
28 as follows:

1 (a) All five trustees currently in office shall continue to serve the balance of their
2 respective terms.

3 (b) Upon the expiration of the term of the trustee whose term expires next in time after
4 the effective date of this Resolution, that seat shall not be filled, and the Board of Trustees shall
5 thereafter consist of four (4) members.

6 (c) Upon the expiration of the next trustee term to expire thereafter, that seat shall not
7 be filled, and the Board of Trustees shall thereafter consist of three (3) members. All subsequent
8 appointments and reappointments shall be made consistent with a three-member board.

9 (d) A trustee position shall be deemed to have expired upon the earlier of (a) the
10 expiration of the trustee's term or (b) the occurrence of a vacancy in that position as defined by
11 Government Code section 1770.
